2025 Marsha Fry FCCLA Memorial Scholarship Application

The Marsha Fry Memorial Scholarship will be awarded to a current Ballinger High School FCCLA member who exhibits outstanding leadership, scholarship, and community service as well as demonstrates well-roundedness through various activities.

Eligibility: Open to a current Ballinger High School FCCLA member who:

- Has been an FCCLA member for a minimum of 2 years
- Is currently a senior (grade 12) in high school
- Has a minimum of 3.0 cumulative GPA (based on a non-weighted 4.0 scale)

Instructions

- 1. Type or print everything neatly.
- 2. Do not alter this form in any way or use abbreviations.
- 3. Complete all sections of the application.
- 4. List information chronologically beginning with the earliest date first.
- 5. Type the essay questions on a separate paper, if necessary.
- 6. Include an official High School transcript.
- 7. Include three (3) reference letters from teachers.
- 8. Applications must be returned by March 6, 2025.
- 9. Return applications to Mrs. Castleberry.

Procedures/Recognition:

Applications will be evaluated for style and expression as well as content by a committee consisting of the High School Counselor, FCS teacher, and two community members. Conciseness of written remarks is recommended.

The \$500 scholarships will be made payable directly to the college/university after the students provide proof of enrollment. The scholarship winners will be announced during the Senior Awards Ceremony. There may be up to three scholarship winners.
